ALSO PLS KINDLY KEEP US POSTED REF ETA AT PIRAEUS EVERY 72/48/24/12

DURING APPROACHING VSL MUST FOLLOW PIRAEUS TRAFFIC SEPARATION ZONE. ONE HOUR BEFORE ENTER TRAFFIC ZONE YOU MUST CONTACT PIRAEUS TRAFFIC STATION ON VHF CH 13.

ANCHORAGE LIMITS 010 DEGREES UP TO 050 DEGREES BEARING FROM ATALANTI ROCK ISLAND.

ATALANTI ROCK ISLAND POSITION:

LATITUDE 37 56 00

LONGTITUDE 23 34 02.

IS A SMALL ROCK ISLAND WEST OF PSITALIA LIGHT HOUSE.

ALWAYS STAND BY VHF CH 13 AND 16 AND FOLLOW INSTRUCTIONS GIVEN FROM PIRAEUS TRAFFIC STATION TO BE GIVE EXACT SAFE ANCHORING POSITION.

ALL MOVES OF THE VESSEL MUST BE REPORTED FROM THE MASTER TO THE PIRAEUS TRAFFIC STATION VHF CH 13.

DURING YOUR STAY YOU MUST ALWAYS STAND BY ( AROUND THE CLOCK ) V.H.F. CHANNEL 13 AND 16 AND ALL INSTRUCTIONS GIVEN FROM ( V.T.S. ) PIRAEUS TRAFFIC CONTROL STATION MUST BE FOLLOWED.

AFTER COMPLETION OF SUPPLIES/BUNKERING/WORKS ETC, CONFIRM BY THE CHRTRS/OWNERS AND HEAVE UP THE ANCHOR AND SAIL FOR NEXT DESTINATION REPORTING SAME TO PIRAEUS PORT CONTROL CH 13.

PLS KINDLY CONTACT WITH TRAFFIC CONTROL AT LEAST ONE HOUR BEFORE VESSEL'S SAILING TIME, AS PER PORT REGULATIONS.

DURING STAY AT PIRAEUS ANCHORAGE VHF STDBY CH 13 AND 16 AND REASONS OF ARRIVAL IS BUNKERS AND OR SUPPLIES.
